

COMPENSATION OF EXPENDITURE FOR OF OPTICAL PRODUCTS PURCHASE FROM EOPYY

INSTRUCTIONS TO THE INSURED FOR THE ELECTRONIC SUBMISSION OF SUPPORTING DOCUMENTS

1. Go to the following website: eopyy.gov.gr
2. Choose: **[ΦΑΚΕΛΟΣ ΑΣΦΑΛΙΣΗΣ ΥΓΕΙΑΣ]**.
3. Log in with your Taxisnet credentials or your personal insurance (EOPYY) number.
(Indirectly insured persons enter the platform with their own credentials unless they are minor protected members)
4. Choose: **[ΥΠΟΒΟΛΗ ΑΤΟΜΙΚΟΥ ΑΙΤΗΜΑΤΟΣ]**.
5. Choose **[ΘΕΜΑ ΑΙΤΗΜΑΤΟΣ]**: "ΟΠΤΙΚΑ".
6. Choose field **[Αφορά]** if it concerns indirectly insured persons (έμμεσο) or directly secured (άμεσο) and add **[ΑΜΚΑ]**.
(Indirectly insured after selecting "indirect member" enter their own AMKA and the rest of their personal data, only in the field [BENEFICIARY DETAILS] enter those of the directly insured. For minor protected members enter their AMKA in the upper left box in the search box)
7. Enter your post code **[Ταχυδρομικό Κώδικα] (ΤΚ)** of your home and some details will be updated automatically.
8. In the field of **[ΠΟΣΟ ΑΙΤΗΜΑΤΟΣ]** the exact amount of the document (receipt) given to you by the store, is to be indicated.
9. Fill in all the other details and in the field **[Αριθμός Γνωμάτευσης]** select the number that coincides with the one that is just below the barcode in the EOPYY Benefit Opinion issued to you by your ophthalmologist.
10. Upload by pressing **[+]** the required supporting documents scanned (legal proof of purchase (receipt), confirmation letter by the optician).
11. Press submission **[ΥΠΟΒΟΛΗ ΑΙΤΗΜΑΤΟΣ]**.
